Mangapapa Union Parish is an unincorporated religious entity, registered as a charity with DIA Charities Services.

Entity's Purpose or Mission

The Motivating Mission Statement of Mangapapa Union Parish is: 'To be His Love, Light and Life'. To bring people to Jesus and wholeness of life, through His Love, Light and Life.

Entity Structure

Mangapapa Union Parish is a Cooperative Venture Church with Methodist and Presbyterian roots. We currently operate under the oversight of the Methodist Church of New Zealand - Te Haahi Weteriana o Aotearoa.

The day to day running of the parish is governed by the laws and regulations of the Uniting Congregations of Aotearoa New Zealand. The parish consists of one congregation governed by the Parish Council, which is now commonly referred to as the 'Leadership Team'.

Our 'Parish Council/Leadership Team' consists of close to 12 people, voted on by the members of Mangapapa Union Parish, with up to 4 of these being the Elders team and the Chairperson being the appointed Church Leader/pastor. Ex-officio members of the Leadership Team include the Assets & Finance Team Chairperson, Children's Ministry Leader, Youth Leader, & Worship Music Team Leader.

The day to day running of the parish is undertaken by the paid staff and many volunteers.

Main Sources of Entity's Cash and Resources

Offerings & Donations = 78% Grants Received = 6% Fundraising = 2% Other Donations & Income = 4% Interest on Investments = 5% Residential Rental Income = 5%

Main Methods Used by Entity to Raise Funds

Tithes & Offerings given each week by the church members.
Garage Sales are used to raise funds for local community mission.

We estimate around 100 volunteers contribute around 300 hours per week to the various activities of the church and it's work in the community.

To provide opportunities for individuals and families to encounter the reality of God's love, healing and salvation through Jesus Christ in the suburb of Mangapapa, and the wider Gisborne Tairawhiti region, and in mission and humanitarian relief and development in several parts of the world.

Additional Output Measures

Rest Home Services taken quarterly by teams - Beetham Village, Te Wiremu, Dunblane.

Mangapapa Church Food Bank - 164 Foodparcels given to Social Workers and Whangaia Police team, for clients of thirteen Social Work agencies in the region.

Hospital Emergency Bags & Baby Packs - this last financial year we have made and delivered 300 Emergency Toilet Bags to 3 Hospital Wards, plus 17 Baby Parcels to Maternity, plus extra neo-natal sized garments for tiny ones, and 12 blankets to Ward 4.

We provide 10 'Bible In School' Teachers in 5 Schools in the district.

Our Teen Youth Groups raised their highest total ever for the World Vision 40Hr Famine - \$8,760. For the past 4 years, they have been the top two Youth Group in NZ for fundraising for the World Vision 40hr Famine, raising over \$8,000 in 2016 (over \$7,500 in 2015).

Mangapapa Church financially supports Medical Training Mission work in Burma/Thailand, with two doctors from the Parish working for Partners Thailand.

We financially support the founders of 'Circuit International', Stuart & Ruth Corlett (former Parish members), working in Burma with small business ventures.

We financially support the RUEL Foundation, Fiji, who provide free Cleft Palate surgery to children in Fiji.

We have assisted financially a Tertiary Student training and touring with EXCEL School of Performing Arts.

We have assisted financially two families with School Fees for their children.

Mangapapa Church is part of the new Gisborne Police 'Te Hahi' initiative, whereby vetted Church teams on a roster rotation, provide 'Pastoral Care' to Police clients, when requested by the Police Whangaia Team.

Additional Information

"It has been some years now Mangapapa Union Parish has been delivering sponge bags to the Mental Health Unit at Hauora Tairawhiti. As you may know, many of our patients arrive in a poor state of self-care with very little and often no possessions and often no home and little way of whanau support. This simple thing, a sponge bag with toiletries, has made a difference to many of our patients. It can give a person back some dignity when they have none. Something they can call their own, 'a gift' - not Hospital supply - which can make them feel cared for. We do appreciate the time and care taken to make these bags up for our patients and understand they come at a cost to your community. As you may know with Hospital cutting, shampoo, conditioner and even combs are no longer supplied. Without the Churches assistance in supplying these, the patients recovery and self esteem would take longer to be restored. Could you please pass on our appreciation to your church and community for these bags. Thank you again for your time and effort and cost of making these."

Statement of Accounting Policies

Mangapapa Union Parish For the year ended 30 June 2017

'How did we do our accounting?'

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Property, Plant & Equipment

Property, Plant & Equipment, except land and buildings, are recorded at cost less accumulated depreciation. Land and buildings are recorded at the latest rating valuation prepared by Land Mass Technology as at July 2014.

Depreciation

Property, Plant & Equipment, except land and buildings, have been depreciated on a straight line basis as follows:

Furniture & Equipment

8.4% - 48% SL

Grants

Grants received are recognised as income, unless there are unfulfilled conditions attaching to the grant. In these cases, the grant is treated as a liability until the conditions are fulfilled.

Income Tax

Mangapapa Union Parish is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in the previous year.
